## 4. FIRST AID MEASURES

### Description of necessary measures

**Inhalation:** First aid measures not required.  
**Skin contact:** First aid measures not required. Cosmetic product and therefore not necessary.  
**Eye contact:** Rinse eyes with plenty of water until no evidence of product remains. Get medical attention if pain or irritation develops.  
**Ingestion:** Dilution by rinsing the mouth and giving water or milk to drink is generally recommended. Contact physician or local poison control center.

### Most important symptoms and effects, both acute and delayed

After eye contact: May cause mild to severe irritation with possibility of permanent eye damage. After skin contact: Repeated or prolonged excessive exposure may cause irritation or dermatitis. After inhalation: Unlikely to occur due to the physical properties of the product. At elevated temperatures, vapors or mists may cause irritation. After ingestion: Ingestion may cause irritation of mouth, throat, digestive tract, diarrhea and vomiting.

### Indication of any immediate medical attention and special treatment needed

After eye contact: Rinse eyes with plenty of water until no evidence of product remains. After skin contact: Rinse affected area with mild soap and water until no evidence of product remains. After inhalation: Remove from exposure area to fresh air. After ingestion: Administer immediately plenty of water. ## 6. ACCIDENTAL RELEASE MEASURES
