4. FIRST AID MEASURES

Description of necessary measures

Inhalation: Remove from exposure area to fresh air. Treat symptomatically and supportively.

After eye contact: May cause moderate to severe irritation. After skin contact: No adverse effects anticipated from normal use. After inhalation: Airborne concentrations of propane and isobutane, the propellants in this product, exceeding workplace standards may cause central nervous system effects and irritation of the throat and lungs with coughing, nausea and vomiting. After ingestion: Ingestion may cause irritation of mouth, throat, digestive tract, diarrhea and vomiting.

6. ACCIDENTAL RELEASE MEASURES
