4. FIRST AID MEASURES

Description of necessary measures

Inhalation: First aid measures not required.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation, with possibility of corneal injury if not removed promptly. After Ingestion: Ingestion may cause pain, burning, swelling and redness in the mouth and throat. Nausea and vomiting may occur. Indication of any immediate medical attention and special treatment needed

6. ACCIDENTAL RELEASE MEASURES
