4. FIRST AID MEASURES

Description of necessary measures

Inhalation:	First aid measures not required.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation, with possibility of corneal injury. After skin contact: Repeated or prolonged excessive exposure may cause irritation or sensitization dermatitis in previously exposed individuals. After ingestion: May be fatal if swallowed and enters airways. Nausea and possible vomiting may occur. After inhalation: Unlikely to occur due to the physical properties of the product. At elevated temperatures, vapors or mists may cause irritation. An allergic reaction cannot be excluded after repeated skin contact.

6. ACCIDENTAL RELEASE MEASURES
