4. FIRST AID MEASURES

Description of necessary measures

Inhalation: First aid measures not required.
Skin contact: First aid measures not required. Cosmetic product and therefore not necessary.
Eye contact: Rinse eyes immediately with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation develops.
Ingestion: Dilution by rinsing the mouth and giving water or milk to drink is generally recommended. Contact physician or local poison control center.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation. After skin contact: Repeated or prolonged excessive exposure may cause irritation or sensitization dermatitis in previously exposed individuals. After inhalation: Unlikely to occur due to the physical properties of the product. At elevated temperatures, vapors or mists may cause irritation. An allergic reaction cannot be excluded after repeated skin contact. After ingestion: Ingestion may cause irritation of mouth, throat, digestive tract, diarrhea and vomiting.

Indication of any immediate medical attention and special treatment needed

After eye contact: Rinse eyes with plenty of water until no evidence of product remains. After skin contact: Rinse affected area with large amounts of water until no evidence of product remains. 6. ACCIDENTAL RELEASE MEASURES

Personal precautions, protective equipment and emergency procedures

Wear skin, eye and respiratory protection as recommended in Section 8. Stop leak if you can do it without risk. Spills present a slipping hazard. Keep unnecessary personnel away. Ventilate spill area if possible. Make sure area is slip-free before re-opening to traffic.

Methods and materials for containment and cleaning up
