4. FIRST AID MEASURES

Description of necessary measures

Inhalation: First aid measures not required.

Most important symptoms and effects, both acute and delayed

After Ingestion: Ingestion may cause pain, burning, swelling and redness in the mouth and throat. Nausea and vomiting may occur.
