4. FIRST AID MEASURES

Description of necessary measures

Inhalation: Move to fresh air. If symptoms persist, seek medical advice.
Skin contact: Rinse affected area with large amounts of mild soap and water until no evidence of product remains. If adverse health effects develop seek medical attention.

6. ACCIDENTAL RELEASE MEASURES
