4. FIRST AID MEASURES

Description of necessary measures

Inhalation: First aid measures not required.
Skin contact: Rinse with running water and soap.

Eye contact: Rinse eyes immediately with plenty of water, occasionally lifting upper and low er lids, until no

After eye contact: Moderate to strong irritation of the eyes (redness, swelling, burning, w atering eyes). After skin contact: Temporary irritation of the skin (redness, swelling, burning). Special protective equipment and precautions for fire-fighters

Shut off all ignition sources Move containers from fire area if you can do it w ithout risk. Apply cooling w ater to sides of containers that are exposed to flames until well after fire is out. Use flooding amounts of water as a fog. Cool the packaging with spray water from a protected area. Remove products unaffected by fire from the hazardous area. Avoid breathing vapors; keep upwind. As with any containerized or pressurized chemicals, in the event of overheating or direct flame contact, evacuate the area to minimize hazard of potential explosion.
