4. FIRST AID MEASURES

Description of necessary measures

Inhalation: First aid measures not required.
Skin contact: First aid measures not required. Cosmetic product and therefore not necessary.
Eye contact: Rinse eyes immediately with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation develops.

Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation, with possibility of corneal injury if not removed promptly. After skin contact: Repeated or prolonged excessive exposure may cause irritation or sensitization dermatitis in previously exposed individuals. After ingestion: Ingestion may cause pain, burning, swelling and redness in the mouth and throat. Nausea and vomiting may occur.
