### 4. FIRST AID MEASURES

#### Description of necessary measures

**Inhalation:** First aid measures not required.  
**Skin contact:** First aid measures not required. Cosmetic product and therefore not necessary.  
**Eye contact:** Rinse eyes immediately with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation develops.

#### Most important symptoms and effects, both acute and delayed

After eye contact: May cause moderate to severe irritation, with possibility of corneal injury if not removed promptly. After skin contact: Repeated or prolonged excessive exposure may cause irritation or sensitization dermatitis in previously exposed individuals. After Ingestion: Ingestion may cause pain, burning, swelling and redness in the mouth and throat. Nausea and vomiting may occur. #### Indication of any immediate medical attention and special treatment needed

### 5. FIRE FIGHTING MEASURES
