First Aid:

SECTION 5: FIRE FIGHTING MEASURES

Fire & Explosion hazards:

Cool uninvolved containers to prevent possible bursting. Aerosols may be projectile hazards when bursting. If aerosols are bursting, stay clear until bursting is complete.
